Effectively Managing Transit Emergencies

Course Overview

This course will provide information on understanding the importance, purpose, development, and implementation of emergency management and how it relates to the other safety functions of a transit system. Participants will learn how to better understand the emergency management concept and the role of the transit system in responding to emergency/disaster situations in both the community and transit system. The course provides information which can be used to introduce emergency management into the acquisition and operational phases of a transit system life cycle and thereby implement or improve emergency management programs. Participants who successfully complete the course will receive Federal Emergency Management Agency (FEMA) Emergency Management Institute (EMI) certificates for IS-100 (ICS), IS-700 (NIMS) and IS-546 (COOP).
